Rollout of Bharat Good Agricultural Practices (Bharat GAP) Certification Programme

Subject: - Notice Inviting Applications for accreditation of certification bodies and empanelment of NABL accredited testing laboratories

National Horticulture Board (NHB), an autonomous body under the Ministry of Agriculture and Farmers Welfare, Govt of India, announces the rollout of Bharat Good Agricultural Practices (Bharat GAP) certification programme.

Bharat GAP certification shall be a voluntary third-party certification system based on ISO-17065 and Bharat GAP standards and procedures. The Bharat GAP Operational Manual can be accessed from NHB Website https://www.nhb.gov.in/BharatGAP.aspx

Bharat GAP certification shall be applicable for following crop categories:

Fresh fruits and vegetables

ii. Flowers and ornamentals and

iii. Combination crops grown in combination with above two categories of crops

Bharat GAP certification can be availed by following category of operators:

Individual producers

ii. Small grower groups without QMS and

iii. Large grower groups with QMS

For implementation of Bharat GAP certification programme, applications are invited for:

- a. Accreditation of certification bodies from eligible agencies fulfilling the criteria laid down under Bharat GAP.
- b. Empanelment of testing laboratories fulfilling the criteria laid down under Bharat GAP.
