Policy Issues:

The following points were discussed/decided.

1. While discussing the current budget and liabilities of NHB, it was desired that the progress report of the schemes and details of projects sanctioned and subsidy amount against the sanctioned projects be placed in agenda note to decide the extent of projects to be approved further.
2. Considering the voluminous agenda notes, it was decided that in agenda summary of each completed project, the concerned division/accounts division may ensure that the scheme's operational guidelines are fulfilled from start of the project, at the time of sanctioning/ completion of the project.
3. Font of summary sheet/agenda note should be clearly visible and legible preferably decent size in Arial 12. All Amount figures should be mentioned in lakhs only and not in rupees with clear cut recommendation of the division duly signed by the concerned Area Officer and dealing officer.
4. Committee was of the view that only summary sheet should be given/ circulated to members as hard copy in physical form and entire volumes of agenda may be sent to Computer Division two days before and Computer division will compile it in PDF format and mails it amongst committee members.
5. Agenda notes may be circulated at least one week in advance to all members.
6. Regarding total time taken by a promoter from issuance of Letter of Intent (LOI) to completion of project, it was desired that a time limit be fixed for various stages like issuance of LOI to sanction of term loan from bank, completion of project and submission of subsidy claim etc.
7. It was also decided that Board may request MoFPI to notify an officer in their Ministry to deal with NHB related projects and a time limit for issuing No Objection Certificate (NOC) in primary processing related horticulture projects be fixed so that Ministry may furnish their NOC to Board.
8. In PHM projects, the existing/newly created infrastructures like civil works, automation & plant and machineries etc should be clearly mentioned with date of construction or date of purchase in pre-inspection report by the field officers and dealing officers in agenda notes.
9. It was also observed that the component(s) making/qualifying the project hi-tech may also be properly described by Joint Inspection Team in case of completed projects.
